# TOWN COUNCIL ACTIONS

## May 13, 2013

- Held a public hearing on proposed water and sewer fees.
- Adopted a tax rate of \$.2288 (or 22.88 cents) per \$100 of assessed value for the Fiscal Year 2013-2014. (*Polychrones voting Nay*)
- Adopted Fiscal Year 2013-2014 water rate of \$4.75 per 1,000 gallons and sewer rate of \$6.66 per 1,000 gallons, effective July 1, 2013.
- Adopted the Fiscal Year 2013-2014 budget in the total amount of \$32,272,761. (*Polychrones voing Nay*)
- Set a public hearing on changes to the Vehicle License Fee ordinance for June 3.
- Awarded a sole source contract for medical services for Town employees to INOVA Health Services of up to \$15,000.
- Awarded a sole source contract for telecommunication services to Siemens Enterprise Communications, with payment of up to \$25,587.72.
- Increased the contract with the Davey Tree Company by \$12,500.
- Awarded a contract to Silver Communications for printing of the Parks and Recreation quarterly brochure in the amount of \$14,389.
- Awarded a contract for additional engineering services to Wiley|Wilson for a total amount of \$26,553 for work on Mill Street NE and Follin Lane SE.
- Approved 206 and 210 Glyndon Street SE and 301 and 303 Locust Street SE subdivision public improvements into the Town system for maintenance and reduced the surety amounts to \$4,886.53 and \$5,118.60, respectively.
- Approved an increase in HD Supply Waterworks by \$4,000 and approved an after-the-fact payment of \$12,481.17.
- Approved an increase in the contract with Sagres Construction Corporation by \$113,184 to complete the Spring Street SE construction project.
- Approved riding Fairfax County contract with Systems Furniture to purchase 11 new chairs for the Council dais for a cost of \$14,719.76 (*Cole Abstained*)

## COMMENT FROM THE COUNCIL TABLE

### Town Green Needs New Friends

It's been six years, and here I am again, asking you to become a patron of the arts in your own backyard. In 2007, I wrote in this space about the brand-new

Vienna Town Green and its summer concert series. I was determined to pay for the concerts with private funds, so they wouldn't be subject to cuts during tight budget times.

It was just me on the phone that first season, raising \$12,000 in sponsorships. But then I was joined by a small cadre of volunteers, and a larger group of donors called the "Friends of the Vienna Town Green." We had special polo shirts, and Friends volunteers staffed a table during

Town Green concerts. We handed out program flyers, with information on how others could donate, too. The Friends donations sponsored several concerts.

A volunteer committee took over much of the fund raising for the second season, and for the third and subsequent seasons a professional fund raiser was brought in. However, that individual has gone on to a new job, and sponsorships are dwindling in the continuing tight economy.

Nearby park concerts are not funded with tax dollars, either. Friends groups in other communities fund the "Nottoway Nights" and "Spotlight by Starlight" (Mason District Park) concerts. Vienna's Summer on the Green attracts hundreds of people each week; we can certainly

match the enthusiasm and tenacity of residents of those other places.

## WOLFTRAP STREAMBED RESTORATION: A CITIZEN'S PERSPECTIVE

What is going on at our local streambed? I asked myself this question recently on my walk along Follin Lane near the Navy Federal Credit Union. I found answers through the Town's website and with Cathy Salgado and Leon Evans with the Town's Department of Parks and Recreation.

Apparently, this has been in the works as far back as 2008 with letters going out to residents in the immediate area. When you drive down Follin Lane you will see large machinery, orange plastic

fencing and a new mulch path detour. Be careful as you pass because it is eye-catching.

This stream restoration project is funded by our Fairfax County Stormwater tax dollars. This is one of many projects selected to amend the negative impact development has had to the natural environment. The primary objective is to prevent further erosion of Wolftrap Creek's banks and expand the aquatic and natural habitat.

The plans are detailed and professional. The project is fully underway and

should be largely completed by Labor Day with the possible exception of fall replantings.

I walked Reston's restored Glade stream and Snakeden stream valleys to get a feel for our streambed's future. I liked the results. I'm looking forward to getting our area "cleaned up". The noticeable deterioration had caught many of my neighbors' attention as well as mine. Please don't panic when many of the debris/trees come out, and when man tries to re-create the natural. We'll likely be better off. I'm still walking and watching with interest.

### A Note From the Town on the Wolftrap Stream Restoration Project:

This project is Vienna's first example of a way to repair natural areas that have been impacted by previous years' development. As the project draws to a close in late August, the Town and Fairfax County will be hosting a special ribbon cutting ceremony to welcome the public to the revitalized area located in Wildwood Park. # THE TOWN OF VIENNA 2013 WATER QUALITY REPORT

## MESSAGE FROM THE TOWN MANAGER


This is the Town of Vienna's fifteenth annual report to inform you about your drinking water quality. As a part of the Safe Drinking Water Act of 1996, the U.S. Environmental Protection Agency (EPA) requires all water utilities across the nation to mail their customers a Water Quality Report by July 1 every year. Our goal is to provide you with a safe and dependable supply of drinking water and we want you to understand our efforts to protect your water supply.

The quality of your drinking water must meet state and federal requirements administered by the Virginia Department of Health and the US Environmental Protection Agency (EPA). We constantly monitor the water supply for various contaminants to ensure we meet all regulatory requirements. The tables in this report list only those contaminants that had some level of detection. Many other contaminants have been analyzed but were either not present or were below the detection limits of the laboratory equipment. Most of our water quality data is from testing done in 2012; however, the Commonwealth allows us to monitor for some contaminants less than once a year because the concentration of these contaminants does not change frequently. Even though some of our data may be more than one year old, it is accurate.

On page two of this report, we have provided detailed information regarding an omission in our sampling requirements in 2012, during which time we did not collect and analyze water samples for lead and copper. In order to rectify this omission, we collected and tested 30 samples between February 19 and 22, 2013 and provided the samples to the Virginia Department of Health. The results indicated that the samples were below the established action levels and we are now in compliance. In addition, we will continue to monitor for lead and copper throughout this year.

## GENERAL INFORMATION

As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and can pick up substances resulting from the presence of animals or from human activity. Substances (referred to as contaminants) in source water may come from septic systems, discharges from domestic or industrial wastewater treatment facilities, agricultural and farming activities, urban storm water runoff, residential uses and many other types of activities. Water from surface sources is treated to make it drinkable. All drinking water, including bottled drinking water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water possesses a health risk. More information can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline at 1-800-426-4791.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Environmental Protection Agency/Center for Disease Control guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline at 1-800-426-4791.

## NOTICE TO CUSTOMERS

In keeping with National Primary Drinking Water Regulations, we are informing you that we may be in violation of state regulations. We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. Vienna is required to test for lead and copper every three years and during 2012 we did not monitor or test or did not complete all monitoring or testing for lead and copper and therefore cannot be sure of the quality of our drinking water during that time. **There is nothing you need to do at this time.**

We are attempting to prevent further violations by ensuring that all required sampling in our distribution system is done in accordance with the state drinking water regulations. Further violations will be reported as required by state regulations in order to increase consumers' awareness of conditions that exist in their public water system.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

## HOW DO I READ THIS CHART?

Our water is tested to assure that it is safe and healthy. Contaminants in the drinking water are routinely monitored according to Federal and State regulations. The table contained in this report shows the most recent results of our monitoring. Typical sources of contamination show where this substance usually originates. The following definitions are provided to help you better understand terms and abbreviations.

- The Washington Aqueduct sampling program includes cryptosporidium. Their results and information are included.
- Non-detects (ND) – laboratory analysis indicates that the contaminant is not present.
- Parts per million (ppm) – one part per million corresponds to one minute in two years or a single penny in \$10,000.
- Parts per billion (ppb) – one part per billion corresponds to one minute in 2,000 years or a single penny in \$10,000,000.
- Parts per trillion (ppt) – one part per trillion corresponds to one minute in 2,000,000 years or a single penny in \$10,000,000,000.
- Picocuries per liter (pCi/L) – picocuries per liter is a measure of the radioactivity in water.
- Nephelometric Turbidity Unit (NTU) – nephelometric turbidity unit is a measure of the clarity, or cloudiness, of water. Turbidity in excess of 5 NTU is just noticeable to the average person. Turbidity is monitored because it is a good indicator of the effectiveness of the filtration system.
- Action Level (AL) – the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Treatment Technique (TT) – a required process intended to reduce the level of a contaminant in drinking water.
- Maximum Contaminant Level (MCL) – the highest level of a contaminant that is allowed in drinking water. MCLs are set at very stringent levels by the U.S. Environmental Protection Agency. In developing the standards EPA assumes that the average adult drinks two liters of water each day throughout a 70-year life span. EPA generally sets MCLs at levels that will result in no adverse health effects for some contaminants or a one-in-ten-thousand to one-in-one million chance of having the described health effect for other contaminants.
- Maximum Contaminant Level Goal (MCLG) – the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Residual Disinfectant Level (MRDL) – the maximum level of total chlorine allowable by regulation.

## PERCHLORATE RESEARCH

Perchlorate is a naturally occurring as well as man-made compound. Its presence in drinking water is currently unregulated and utilities are not required to monitor for it. The Washington Aqueduct has been voluntarily monitoring for perchlorate since 2002. The EPA initially established a reference dose of 24.5 parts per billion (ppb) for perchlorate and beginning in 2009 has proposed an interim health advisory of 15 ppb. A reference dose is a scientific estimate of a daily exposure level that is not expected to cause adverse health effects in humans. The reference dose concentration was used in EPA's efforts to address perchlorate in drinking water and to establish the interim health advisory. In 2011, finished water sample results for perchlorate collected by Washington Aqueduct at both treatment plants ranged between none detected and 3.7 ppb. ## LEAD IN DRINKING WATER

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of Vienna is responsible for providing high quality drinking water, but cannot control the variety of materials used in private plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 15 to 30 seconds or until it becomes cold or reaches a steady temperature before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## TURBIDITY IN DRINKING WATER

Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

## OPPORTUNITIES FOR PUBLIC PARTICIPATION

Decisions concerning Vienna's water are made by the Town Council. Regular meetings are normally held the first and third Mondays of the month (except July and August) at 8 p.m. in the Council Chamber at Town Hall.

## WATER SOURCES

For the calendar year 2012, the Town of Vienna was supplied with treated surface water from the Potomac River by the Fairfax County Water Authority (FCWA) and the City of Falls Church. The Town purchases treated water from the Washington Aqueduct supplied by Falls Church.



## 2012 SOURCE WATER CRYPTOSPORIDIUM INFORMATION

Cryptosporidium was monitored in the source water monthly in 2012 but was not detected in any sample. The only detection of Cryptosporidium that has occurred since the initiation of source water monitoring was in October 2005.

## 2012 SOURCE WATER GIARDIA INFORMATION

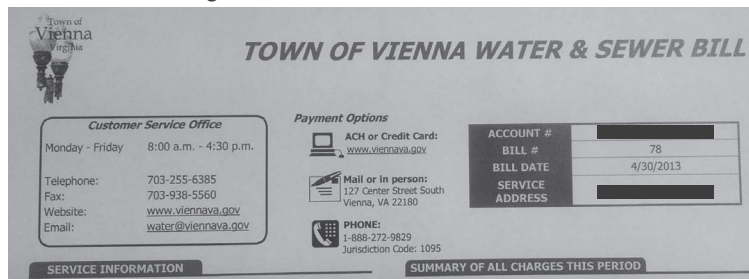
Giardia was monitored in the source water monthly in 2012. One Giardia cyst was detected in one sample resulting in a single detected concentration of 0.19 cysts/L for February 2012.

## THIS MONTH IN HISTORY

*From the Vienna Newsletter Archives*

**July 2003:** Vienna's Community Enhancement Commission recognized Robert Zillian, 507 Heritage Lane NW, with a Beauty Spot Award for his construction of a safe and comfortable school bus stop at 618 Upham Place NW.

**July 1993:** In response to a request from the Town, the Virginia Department of Transportation (VDOT) has installed a "No Turn on Red When Pedestrians are Present" sign on southbound Nutley Street at Virginia Center Boulevard to improve pedestrian safety near the Vienna Metro Station. VDOT also studied the timing of the pedestrian signal at that intersection and concluded that sufficient crossing time exists.

**July 1983:** A Gamefield Fitness Course, featuring 15 exercise stations, is now open behind the Community Center along the W&OD Trail. The facility is designed for use by senior citizens, but persons of all ages and levels of fitness can benefit from the exercises. Each station has a descriptive sign to guide participants through the exercise.

**July 1973:** Among the special events scheduled for this year's July 4th celebration at the Community Center are entertainment by Paul Puckett and The Country Folk with special guest star Charlie Waddell, the singing State Senator, and the Vienna Volunteer Fire Department will conduct a flying watermelon contest with a fire hose.
