TOWN ELECTIONS REMAIN YEARLY

As a result of some confusion over recent changes in the State laws governing elections, the State Board of Elections mistakenly advised many people who made inquiries that there would be no Town elections in Vienna this year.

When Town officials became aware of this, they investigated the matter and, through Delegate Wyatt Durette, requested the State Attorney General to give an opinion. He agreed that there had been a misinterpretation of election laws. Vienna will continue having yearly elections as specified in its Charter.

The Town election will be held on the first Tuesday in May to decide on three Council seats. Councilman L. Dean Wallace has announced that he will not run for re-election. The other two Councilmen, Neil Walp and Robert Skahan will seek to retain their seats.

This year's election will be held at the Community Center. Previously Town elections were held at the Town Hall. The space used however, has been made into additional offices, and is no longer available.

The closing date for filing for candidates in the Town election is March 6.

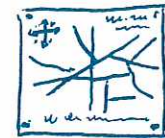

NEW STREET MAP APPROVED



Vienna's Map of Proposed Arterial, Collector and Local Streets, a part of the Traffic Circulation Plan to be included in the new Comprehensive Plan for the development of the Town was adopted by the Town Council at a special meeting on January 29.

One new road and extensions of several existing roads were included in the new plan. The new road will be the much discussed second access road into Vienna's Technology Park. It will extend from Park Street, along the old Railroad right-of-way, border the Technology Park, and connect with Electric Avenue. Although roughly paralleling the old railroad track, the actual alignment and position will depend on the results of surveys now in progress.

Two streets, previously considered for extension, will now end in cul-de-sacs. These are Nutley Road at its southeast terminus in Victoria Woods, and Upham Road on its eastern end. A barrier will be removed to connect Upham with Holmes Drive.

Street extensions include Center Street to the northern corporate limits and Mill Street. These two roads will bend and meet together close to the town line. The East Street extension will connect the two segments of that road between Creek Crossing and Maple Avenue, and an extension of Talahi Road will connect with Branch Road.

The new map will show Church Street extended to connect to Pleasant Street. This takes into consideration the possibility of a new postoffice being constructed on Lawyer's Road at Church Street, and may or may not be required. A park road through Southside Park will connect Ware Street with Patrick Street for easier circulation of traffic to and from the ball fields.

VIENNA LOSES ITS RECYCLING CENTER

Vienna has lost its recycling center - for the present at least. The Vienna Town Council was forced to turn down Ecocycle's application for increasing the amount of land used by its operation from 8000 sq. ft. (as set in the ordinance), to 12,000 sq. ft. which Ecocycle felt was required to continue operating.

Ecocycle wished to use the land both for collection and for installing machinery to crush glass and tin cans. However, since the site did not drain properly and was constantly muddy, Town help was necessary to surface the area.

Council could not agree to spend Town money to assist with the necessary soil compacting and paving, since Ecocycle leased the property on a month to month basis from Galliher Lumber Co., and could be required to vacate at any time. Since additional space was useless without proper paving Council did not grant the request. No other logical space exists within the Town at present for a recycling center. We will therefore, be without this service for a time.
