



VIENNA POLICE HIGHLIGHTS

March 29, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from March 22, 2019 – March 28, 2019. Readers are reminded that an “arrest” is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court’s website.

Suspicious Event 19-002909

Marshall Road Elementary School

March 20 5:23 p.m.

A resident reported that a student made threatening remarks to her daughter in school. The school administration is addressing the incident with the other student.

Vienna Police Department to Participate in the D.E.A. Prescription Drug Take Back Initiative

Saturday, April 27, 2019 from 10:00 a.m. to 2:00 p.m.

In conjunction with the United States Drug Enforcement Administration (D.E.A.) and state and local law enforcement agencies, the Vienna Police Department will again participate in a one-day initiative to remove potentially dangerous controlled substances from area homes.

On April 27, 2019, between the hours of 10:00 a.m. and 2:00 p.m. the Vienna Police Department will have a collection site for old, expired, unused, or unwanted medications. Prescription medications, controlled or non-controlled substances, and over the counter drugs may be turned in anonymously at the collection point inside the Vienna Police Department located at 215 Center Street, South, Vienna, Virginia 22180.

Participants may dispose of medication in its original container or by removing it and disposing of it directly into the collection box. If an original container is used the individual should consider removing any identifying information from the prescription label.

Liquid products should remain sealed in their original container to prevent leakage.

Intravenous solutions, injectables, and syringes will not be accepted due to associated hazards.

Commercial businesses, pharmacies or other medical facilities may not use this as a means to discard expired medications or medical waste.
