



# VIENNA POLICE HIGHLIGHTS

October 25, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from October 18, 2019 – October 24, 2019. Readers are reminded that an “arrest” is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court’s website.

## ***INCIDENTS***

### **Suspicious Vehicle 19-010891**

**200 Block Pleasant Street, SW**

**Between August 4 3:30 p.m. and October 22 10:40 a.m.**

A resident reported a suspicious vehicle that regularly parks in front of their house.

A citizen reported that an emotionally disturbed person kicked his vehicle and damaged it. The victim was advised on the process of obtaining a warrant for the destruction of his property. The emotionally disturbed person was transported to the hospital for medical attention.

An employee requested police assistance with a subject that was found sleeping inside the restroom. The subject was officially trespassed from the property and left the premises without further incident.

An elderly resident received a call from someone claiming to be from the Social Security Administration, stating that her social security number had been compromised and that a vehicle registered to her had been located in another country, containing illegal drugs. The resident was asked to verify her name, date of birth and social security number, which she did. The caller then asked the victim to verify her credit card and bank account details, which the victim did not do because the bank name provided was not correct and she got suspicious. The victim called her son and learned that it was a scam.

Officers responded to a report of an open door. Officers searched the residence and did not locate anyone.

**Arrest – Attempted Unlawful Entry & Drunk In Public 19-010817**

**October 20 between 12:50 a.m. and 1:00 a.m.**

A resident reported that a man attempted to enter their home by pulling on a glass sliding door and telling the homeowner to come outside. The resident refused, and the subject got belligerent and started to yell profanities. The subject left the scene prior to police arrival but was quickly located in the area by an officer. During the interaction with officers, it was obvious that the man was extremely intoxicated.

Officer Borja arrested the 37-year-old man from Willow Forest Court in Clifton, Virginia, and transported him to the Fairfax County Adult Detention Center where he was charged with Drunk In Public & Attempted Unlawful Entry. The man was given a \$2,000 unsecured bond and remanded into the custody of the Fairfax Deputies.

PFC. Williams observed a driver commit traffic infractions and initiated a traffic stop. Upon the officer's interaction with the driver, he detected signs of impairment. After the driver failed to complete a series of field sobriety tests successfully, he was placed under arrest. He was transported to the Vienna Police Station, where he provided a sample of his breath for analysis.

PFC. Williams transported the 30-year-old man from Banship Drive in Herndon, Virginia, to the Fairfax County Adult Detention Center where he was charged with Driving While Intoxicated.

Vehicle-2 was parked unoccupied and had its left side mirror struck.

**Between October 19 10:00 p.m. and October 20 11:00 p.m.**

Vehicle-1 and Vehicle-2 were both southbound on Park Street, SE, when Vehicle-2 stopped for the stop sign at Tapawingo Road. Driver-1 did not realize Vehicle-2 stopped and struck Vehicle-2 from behind. Vehicle-2 was then pushed forward into Tapawingo Road as Vehicle-1 veered off the roadway (right) and damaged the stop sign.

Driver-1 was issued a summons charging Failure to Pay Full Time and Attention.

Vehicle-2 was stopped in traffic at the stop sign on Kingsley headed towards Nutley Street and was rear-ended by Vehicle-1. The driver of Vehicle-1 got out briefly, however refused to exchange information and drove off.

Vehicle-1 veered over into the right lane and struck Vehicle-2 on the driver side front door with its front right fender/headlight area. Both vehicles had minimal damage.

Vehicle-1 was making a left hand turn onto Nutley Street, S from Tapawingo Road. Vehicle-2 was stopped on Nutley Street, S. Vehicle-1 rear-ended Vehicle-2.

#### **Vienna Police Department to Participate in the D.E.A. Prescription Drug Take Back Initiative**

**Saturday, October 26, 2019 from 10:00 a.m. to 2:00 p.m.**

In conjunction with the United States Drug Enforcement Administration (D.E.A.) and state and local law enforcement agencies, the Vienna Police Department will again participate in a one-day initiative to remove potentially dangerous controlled substances from area homes.

On October 26, 2019, between the hours of 10:00 a.m. and 2:00 p.m. the Vienna Police Department will have a collection site for old, expired, unused, or unwanted medications. Prescription medications, controlled or non-controlled substances, and over the counter drugs may be turned in anonymously at the collection point inside the Vienna Police Department located at 215 Center Street, South, Vienna, Virginia 22180.

Participants may dispose of medication in its original container or by removing it and disposing of it directly into the collection box. If an original container is used the individual should consider removing any identifying information from the prescription label.

Liquid products should remain sealed in their original container to prevent leakage.

**Intravenous solutions, injectables, and syringes will not be accepted due to associated hazards.**

**Commercial businesses, pharmacies or other medical facilities may not use this as a means to discard expired medications or medical waste.**

### **Reminder**

### **Prevention of Stolen Vehicles/Vehicle Tamperings**

With the advent of warmer weather, the Town of Vienna Police Department would like to remind all Town of Vienna residents to secure their vehicles and personal belongings. Recently there have been several vehicle tamperings to include stolen vehicles from Vienna and the neighboring jurisdictions.

The Vienna Police Department would like to remind citizens of the following steps to assist in the prevention of your vehicle being tampered with or stolen:

#### **Lock your Car Doors.**

The majority of the vehicles being entered and/or stolen have been unlocked.

#### **Remove all Valuables.**

In most cases, the subjects responsible for these acts have been targeting vehicles which contain valuables such as, but not limited to, laptop computers, GPS's, pocketbooks/purses, loose change, cameras, etc. If you must leave valuables in your vehicle, please be sure to conceal the items, in the trunk, under the seats or use any other means to make them undetectable. Also, make sure to record all serial numbers, and if possible, engrave them or permanently mark the items with easily identifiable markings, in the event the items are recovered.

#### **Remove all Keys.**

The subjects who commit these crimes are aware that most new vehicles come with valet keys. Most of these keys are kept inside the vehicles, either in the center consoles, or the glove compartments or other areas easily accessible. In some instances the owners have left their keys rings containing their house keys, providing access to their homes.

#### **Report Suspicious Activity**

In some cases, the subjects have been observed wearing several layers of clothing, not consistent with the weather conditions. This is used to conceal stolen items and also to make identification difficult as they will shed layers of clothing as they flee the area when they suspect they have been observed committing a crime.
