Rabies Clinic

A rabies vaccination clinic for dogs and cats will be held at the Fairfax County Animal Shelter, 4500 West Ox Road in Fairfax, on Sunday, February 24, from 12 noon to 2 p.m.

Vaccine for animals over a year old costs \$6 and gives protection from rabies for three years. Vaccine for animals under a year old costs \$4 and protects for one year.

Certificates will be given to pet owners at the clinic to verify each vaccination. For more information, call the Animal Shelter at 830-1100.

Town ordinance requires all dogs and cats over six months old to be vaccinated.

Public Hearing on Community Center Addition

The Town Council will hold a public hearing on the proposed expansion of the Vienna Community Center at 8 p.m. Monday, February 18, in the Community Center auditorium. The purpose of this hearing is to receive comments from citizens and Community Center user groups on the final design of the addition.

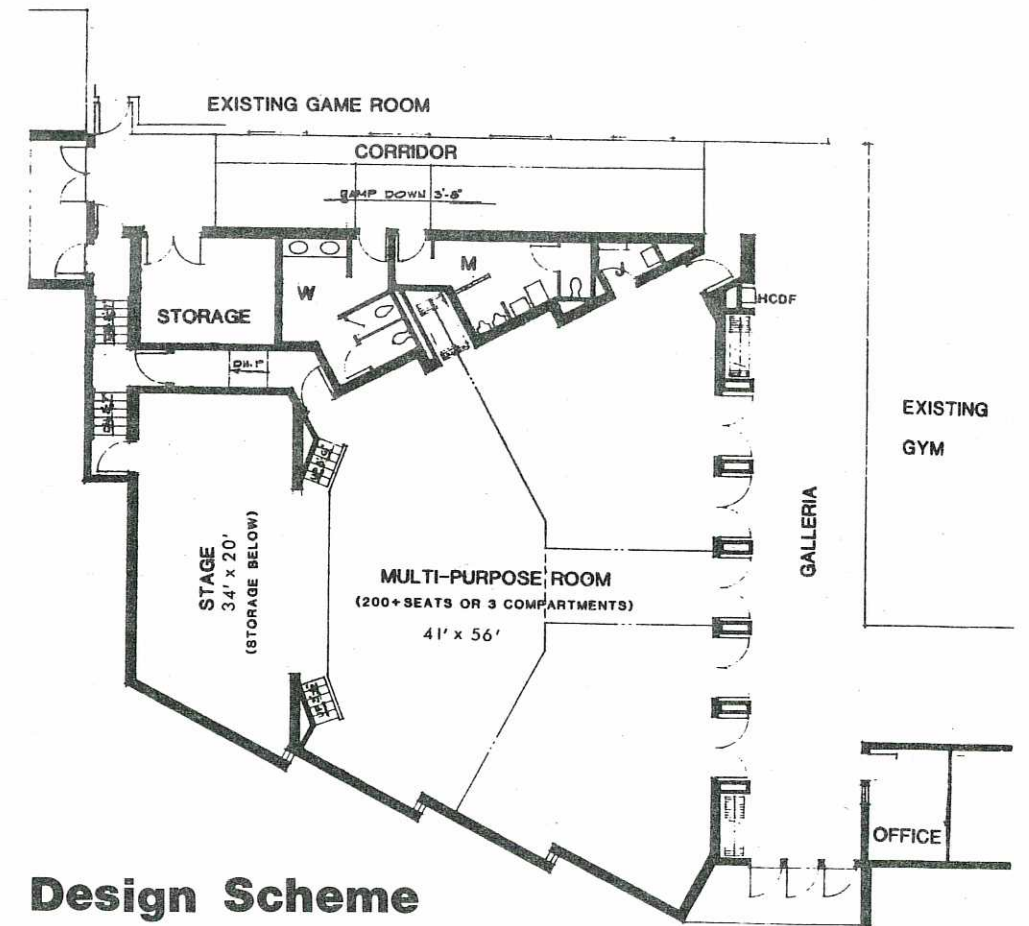
Shown in this *Newsletter* are the two basic designs developed by Peake-Howell Partnership, architects. The firm has offered several options at costs ranging from \$390,545 to \$511,895. These estimated figures include design and engineering, construction, site work, and a ten percent contingency. To date, Council has designated \$425,000 of public improvement bond funds for this project.

Plans showing the various design options and their respective estimated costs will be on display in the Community Center lobby after February 1. The Parks and Recreation Department is also preparing an information packet on the proposed addition, which will be available to the public in early February.

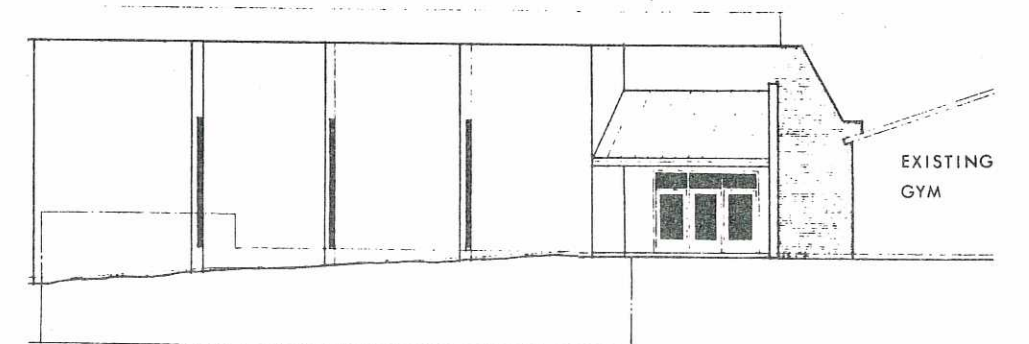
The addition is to be constructed in what is now the patio area and attached directly to the existing build-

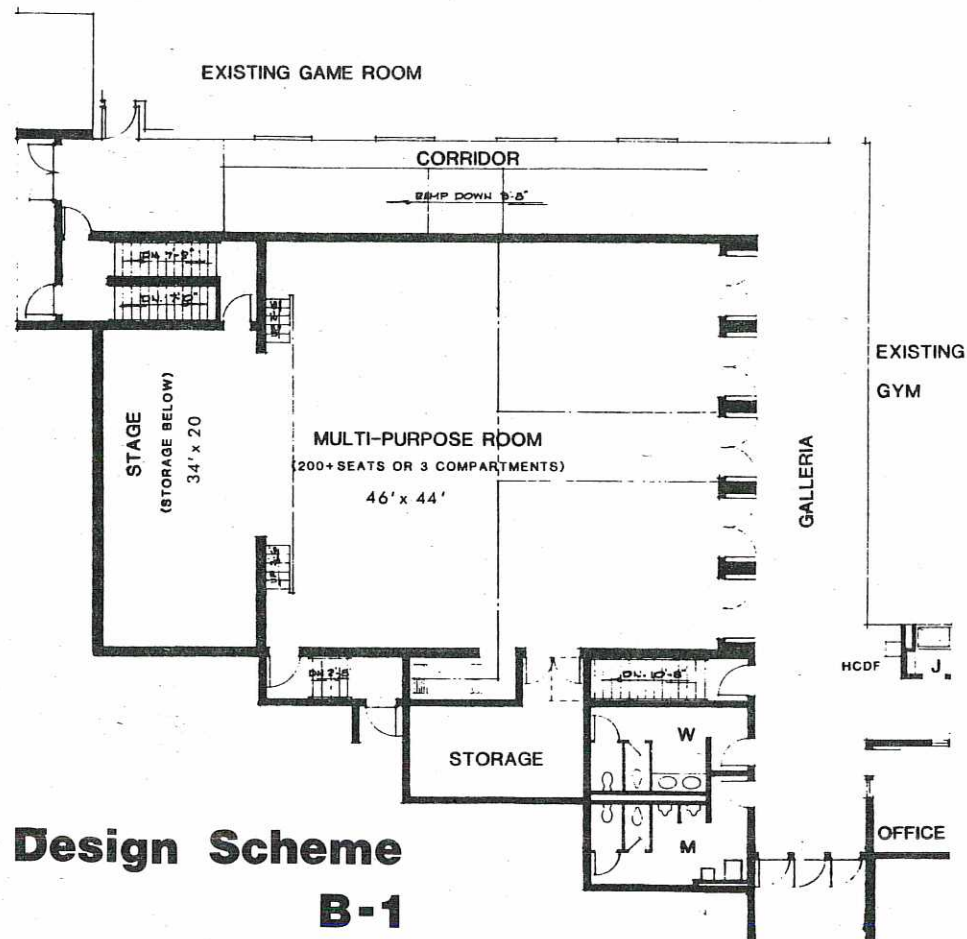

Town Hall will be closed Monday, February 18, for Washington's Birthday. There will be no trash pickup that day.

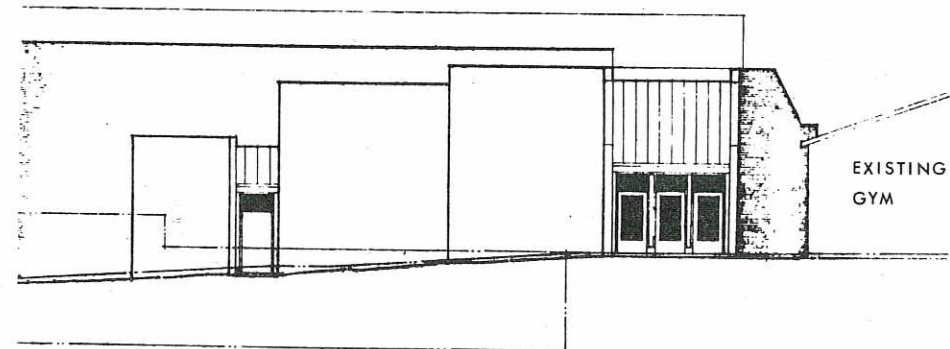


Design Scheme A-1

ing. Both basic plans include a multi-purpose room with a permanent stage and seating capacity of just over 200 persons. A ramp will connect the main floor to the lower level, restroom facilities will be accessible to the handicapped, and additional storage and office space are planned. The main level is approximately 6,300 square feet in area with the optional basement of some 3,300 square feet.

This multipurpose addition to the Community Center has been proposed to help meet the increasing demand for activity and meeting space and to reduce the number of scheduling conflicts. It is intended that the existing gymnasium/auditorium be used primarily for sports and physical activity programs, while the addition will be used for meetings, receptions, plays, concerts, bazaars, exhibits, and other special events.

Two Pre-budget Public Hearings

The Town Manager will hold a pre-budget public hearing at 8 p.m. Tuesday, February 19, at Town Hall.

At this hearing, the Town Manager will accept requests from organizations seeking donations of Town funds during fiscal year 1985-86. Requests must be made in writing, accompanied by a copy of the organization's budget, a current financial report listing all sources of revenue, and a breakdown of how many members are Vienna residents.

The Town Council will receive citizen input at a pre-budget hearing on Monday, February 25. The hearing will be part of the regular Council meeting, which begins at 8 p.m. at Town Hall.

All citizens are encouraged to attend the hearing and express their views on what items should be given priority in preparing the budget for the next fiscal year.

Town Council Action . . .

December 17, 1984

- Conducted a public hearing on a request by Texaco, Inc., to rezone Lots 28 and 28A, 252 Maple Ave., W., from C-1A and RS-16 to C-2 and RS-16.
- Appointed Hector Allen Special Assistant effective January 1 and then Acting Town Manager effective January 26. His salary was set at \$1,000 per week.
- Requested the Transportation Safety Commission to reconsider placing a three-way stop at Locust and Center Streets and make a recommendation to Council.
- Adopted an ordinance to prohibit bringing brush, trash and other discards into town for disposal.

January 7, 1985

- Extended until March 15 the deadline for public expressions of interest in the Moorefield house.
- Presented a \$2,500 donation to the Wolftrap Foundation's Filene Center rebuilding fund on behalf of the citizens and businesses of Vienna.
- Approved an additional \$23,924.27 for the Orchard St. rehabilitation project. Since the overrun is due to contractor errors, the Town Manager and Town Attorney are to take action to collect \$21,517.22 from the engineering firm.
- Adopted an ordinance to prohibit parking of trash trucks in residential zones at any time, excluding Town trucks parked on Town-owned property.

Robert Skahan

The Town of Vienna has lost a dedicated citizen, Robert J. Skahan, who died in late December.

Mr. Skahan was a Town Councilman from 1970 to 1975. He had also served on the Board of Zoning Appeals and the Highway Safety Commission.

Always active in community affairs, Mr. Skahan was a member of Westbriar Civic Association, Our Lady of Good Counsel church, and the Greater Vienna Chamber of Commerce. As an attorney practicing in Vienna, he was a member of several state and local bar associations, and he was also an officer in the U.S. Naval Reserve.

Contributions may be made in Bob Skahan's name to the American Heart Association.

Lions Continue Service to the Deaf

The Vienna (Host) Lions Club, as a service to the traveling deaf and hearing-impaired public has donated a TDD (telecommunications device for the deaf) to the Dulles Airport desk of the Travelers Aid Society. This donation is the most recent action by the club in fulfilling its commitment to TEDI (Telecommunications Exchange for the Deaf, Inc.) and the community in helping the hearing impaired.

Service provided to the deaf by Travelers Aid at Dulles includes airport conditions, flight arrival and de-

parture times, meeting and enrouting passengers, and other information. Those requesting reservations are referred to an airline or travel agency equipped with a TTY/TDD.

The TDD number at Dulles is 471-9776. The voice number of the desk is 661-8636. The 24-hour number for the Travelers Aid Society (voice only) is 347-0101.
