



VIENNA POLICE HIGHLIGHTS

May 19, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from May 12, 2023 to May 18, 2023. Readers are reminded an “arrest” is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court’s website.

On July 1, 2021, citizens will be able to access Community Policing data via <https://data.virginia.gov/stories/s/rden-cz3h>. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

UPDATE – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

INCIDENTS

Animal Case 23-004249

700 Block MacArthur Avenue, NE

May 8 12:00 p.m.

On May 15, a resident reported a few incidents involving a dog in his neighborhood. According to the resident, on May 8, while walking their dogs, the neighbor's dog bit the resident's dog, causing a puncture wound. Both dogs had up-to-date rabies vaccinations. Another incident occurred on May 12 when the neighbor's dog got loose and attacked a cat and a raccoon, resulting in the death of a raccoon. The Animal Control Officer in Fairfax County investigated these incidents and placed the dog under a 10-day quarantine. ACO Barker had a conversation with the dog's owner, emphasizing the importance of ensuring the dog does not pose a threat to other people or animals in the future.

On May 16, the Health Department informed ACO Barker that the test results for the raccoon killed by the dog came back positive for rabies. The owner of the dog was promptly notified, and the quarantine period was extended to the required 45 days.

Destruction of Property 23-004192

May 11 between 5:00 p.m. and 7:00 p.m.

A resident reported someone damaged the tire on her vehicle.

Arrest – Domestic Assault 23-004172

Patrick Street, SE

May 12 2:16 a.m.

Officers responding to the report of a domestic assault in progress located a man and two women outside the apartment building. The man advised they were all out at a bar drinking when he and his girlfriend got into an argument. The man returned home to his apartment. When his girlfriend returned to the apartment with her friend, the argument escalated and she began assaulting him, causing minor injury to his face and head.

Ofc. Garcia arrested the 25-year-old woman from Patrick Street, SE in Vienna. She was transported to the Fairfax County Adult Detention Center where she was charged with Domestic Assault and Drunk In Public, and an Emergency Protective Order was served on her.

A resident reported someone damaged his mailbox.

Arrest – Driving While Intoxicated and Accident 23-004190

Locust Street and Branch Road, SE

May 12 3:10 p.m.

Vehicle-1 was traveling eastbound on Locust Street at the intersection of Branch Road when the driver lost control, went over the curb, and struck a utility pole. Upon the officer's interaction with the driver, they detected signs of impairment. Rescue personnel responded and transported the driver to an area hospital for treatment.

Ofc. Ebrahimi responded to the magistrate's office where a warrant charging Driving While Intoxicated was issued for the man. The officer served the warrant at the hospital on the driver, a 69-year-old man from Janet Lane in Vienna. The driver was released on his signature.

A resident reported his girlfriend took some of his belongings when she was moving out of their apartment. The woman was notified and denied taking any of his property. After speaking to his girlfriend, the resident advised the officer the incident was a misunderstanding and no crime was committed.

Officers responded to the report of a domestic assault. A resident advised she and her husband were arguing when he began to strike her and strangle her, causing minor injury. The man left the area before officers arrived. The resident declined any medical treatment.

Ofc. Reed obtained a felony warrant charging Strangulation and a misdemeanor warrant charging Domestic Assault. At approximately 1:00 p.m., Ofc Ebrahimi located the man inside his residence. She arrested the 45-year-old man from Church Street, NW in Vienna, and transported him to the Fairfax County Adult Detention Center where the two warrants and an Emergency Protective Order were served on him.

Sexual Assault Suspect Arrested

On May 15, 2023, the Vienna Police Department received a report of a sexual assault case involving a minor victim. The incident occurred when the suspect met the juvenile female online through a social media app, engaged in a sexual encounter with her at a park in Vienna. Detectives from the Criminal Investigations Section, dedicated to this case, conducted interviews with the victim and witnesses, coordinated a forensic rape examination, and obtained search warrants.

The suspect, identified as Calvin Aragon Flores, residing in the 100 Block of Patrick Street SE in Vienna, was successfully apprehended by the detectives on May 18, 2023. He has been formally charged with sodomy, rape, aggravated sexual battery, and animate object penetration. As the case progresses, additional charges are expected to be filed.

The Victim Services and Child Protective Services have been notified and will provide the necessary assistance and ongoing support for the victim.
