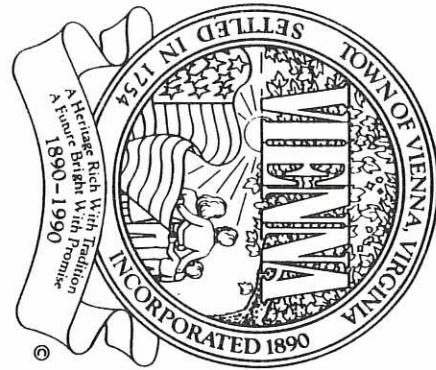

Boundary Adjustment Hearing

The Town Council will hold a public hearing on Monday, August 26, on a proposed boundary adjustment with Fairfax County. The hearing will begin at 8 p.m. in the Council Chamber at Town Hall.

Selection of areas to be included in the boundary adjustment was guided by a number of criteria, including elimination of bisected lots, better delivery of municipal services, and simplification of the boundary line.

The proposed boundary adjustment involves six areas:

AREA NO. 1 - Would bring the entire length of Cynthia Lane, Druid Hill Road and Nelson Drive into the town. The Town and County staffs have recommended that this area be dropped from consideration at this time due to a 50/50 split in opinion on a boundary change among the affected residents.

AREA NO. 2 - Would bring into town the Wall Street water tank property, which is owned by the Town, and place in the county a portion of Freedom Hill Park now located in town.

AREA NO. 3 - Located at the intersection of Glyndon Street and Williams Avenue, portions of two properties would come into town and four homes would go into the county.

AREA NO. 4 - Includes all property east of Nutley Street between the existing town limits and Interstate 66, known as Town & Country Estates; survey results showed an even split in opinion among these residents on a bound-

ary change. Also includes three lots now in town but south of I-66; two of the three property owners there oppose the change. It has been recommended that this area be dropped from consideration.

AREA NO. 5 - This area comprises two separate units, the first extending the west town boundary to James Madison Drive and proceeding south across Maple Avenue along the rear lot lines of the properties facing Nutley Street until reaching Courthouse Road. The second unit places all of James Madison High School in the county along with the entire parcel at the end of Carey Lane, and brings into town properties on Oak Vale Court, Jerry Lane, Burton Place and Roberts Drive.

AREA NO. 6 - This area also comprises two units. The first would bring into town the portion of the Northside Park property now

Notices Sent To 9,000 Water Users

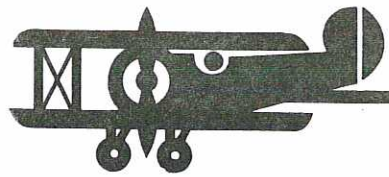
Approximately 9,000 Town of Vienna water customers were notified recently of a violation of federal drinking water standards caused by a sampling error.

Of 30 water samples taken at random in the Town's system during May, three initially tested positive for total coliform bacteria. Total coliforms are common in the environment and are generally not harmful themselves. However, their presence may indicate a more serious problem with water treatment or with the pipes that distribute the water.

When the Town was notified of the positive water samples, the three locations were re-tested the same day, this time with negative results. And during the June sampling period, another 30 samples were taken - all negative.

The Town of Vienna feels that the initial positive test results obtained in May were due solely to sampling errors. These can occur if the person taking the sample touches the inside of the sample container, or if the outdoor spigot from which the sample is taken is not properly disinfected. Based on the original and follow-up sample results for May and the good overall history of Vienna's water system, the Town feels confident that this violation was due to an error in sampling technique and not a water quality related problem.

TOWN COUNCIL ACTION

JUNE 3, 1991

- Following a public hearing, set the water and sewer rates for fiscal year 1991-92.

- Adopted a resolution commending the Vienna Jaycees on "Project Re-Dial."

- Adopted the Town budget for fiscal year 1991-92, and set tax rates as follows: real estate, 29 cents per \$100 of assessed value; bank net capital, 80 cents per \$100 evaluation; utility, 20% of the first \$15 for residential and 15% of the first \$300 for commercial. The budget includes the transfer of \$338,981 from the meals tax revenue account to the debt service reserve in the general fund.

- Awarded a bid for renovation of the Community Center vestibule to Vienna Glass Co., Inc., in the amount of \$7,492.

- Adopted amendments to the erosion and siltation control ordinance.

- Approved an increase in fines for violations of the zoning code.

- Agreed to submit a resolution and/or letter to the Fairfax County Board of Supervisors supporting the Vienna Volunteer Fire Department's opposition to the imposition of the \$100 fee for emergency ambulance service.

JUNE 17, 1991

- Conducted a public hearing on proposed revisions to requirements for the planting and replacement of trees in subdivisions.

- Approved the installation of "No Parking" signs on both sides of Kingsley Road, S.W., at Frederick Street, the distance to be determined by the Police Department but not to impede on private driveways, in a westerly direction toward Nutley Street. The matter of "No Parking" signs on the east side of the intersection was referred to the Trans-

portation Safety Commission for a recommendation.

- Designated the house at 720 Center St., S., as a historic structure.

- Authorized the Town staff to issue a request for proposals to design the renovation of the Maple Avenue business corridor.

- Adopted amendments to the Town employee personnel policies and procedures manual concerning grievance procedures.

- Authorized the Town staff to prepare plans and specifications for the following sidewalk projects (one side of the street only):

1. Tapawingo Road from Frederick Street to the W&OD Trail;
2. Church Street from Glyndon Street to Beulah Road;
3. Moore Avenue from Cottage Street to Ninovan Road;
4. Plum Street from Courthouse Road to Cottage Street;
5. Creek Crossing Road from East Street to Fairway Drive;
6. Pleasant Street from Courthouse to Maple Avenue;
7. Nutley Street from Maple to the Town property yard; and
8. Jiffy Lube property at Maple and Courthouse.

A public hearing on these projects will be held on October 21.

- Approved the following capital improvement projects:

1. Installation of a monitoring system for the underground fuel storage tanks at the Nutley Street property yard;
2. Replacement of the six-inch water line on Malcolm Road; and
3. Replacement of the Westbriar and Coral Gables Pumping Stations.

BUSINESS PERSON AND CITIZEN OF THE YEAR AWARDS

The Greater Vienna Chamber of Commerce wishes to enlist your help in selecting nominees for the Business Person and Citizen of the Year awards.

The awards program seeks to recognize those persons who make a distinctive contribution to improving the quality of life or the general good of members of our community.

QUALIFICATIONS:

1. The nominees must contribute above and beyond normal performance of business activity.
2. Efforts must be sustained over a long period of time and/or result from an outstanding one time contribution in the last 13 months (July 1990 - August 1991).
3. Eligible recipients must have a business or residential address within the Greater Vienna area.
4. The "Business Person of the Year" must be nominated from the business community and the qualifying contribution must be the result of efforts not directly related to his or her normal business activity. Officers and Members of the Board of Directors of the Greater Vienna Chamber of Commerce will not be eligible.
5. The "Citizen of the Year" must be nominated from the non-business community. Eligibility will be dependent upon the nominee's significant contribution to the betterment of the community.

The deadline for receipt of nominations will be September 12, 1991

Persons receiving awards will be honored at a special luncheon in October.

SUBMISSION OF NOMINATIONS

To expedite the submission of nominations, the following guidelines are offered to nominators:

1. Submit a concise basic statement (not more than three pages in length) which contains the following information:
 - ◆ Identification of the nominee
 - ◆ A description of the achievement as such, and a description of the nominee's role, extent of responsibility and extent to which the achievement exceeds normal performance or business activity or has contributed significantly to the betterment of the community
 - ◆ Citations of tangible evidence demonstrating the stature of the achievement
 - ◆ Identification of the nominator
2. To the extent feasible, supplement the basic nomination statement with pertinent exhibits, such as documents, testimonials, news stories, or other similar supporting evidence.
3. If the nominator wishes to have any of the supporting material returned when it has served its purpose, this should be clearly specified.
4. Note the cover sheet form on the reverse side of this page. It is designed to provide quick, positive identification of each nomination. Use the reverse side as the cover page for your nomination.

Don't Become a Victim of Heat Emergencies This Summer

Your Fairfax County Fire and Rescue Department cautions citizens that the heat of summer is upon us and, despite repeated warnings, hundreds of people die or are hospitalized for heat-related illnesses each year. Individuals in poor physical condition, young children, the elderly and the obese are highly vulnerable. It is important not to leave children or animals in cars with the windows closed. To prevent heat-related illness this summer avoid prolonged exercise and labor, drink plenty of fluids, and rest frequently.

Major heat emergencies include:

Heat cramps: muscular spasms and pain resulting from salt loss through sweating or inad-

quate salt intake, usually affecting abdominal, leg and arm muscles. Treatment consists of removal from the hot environment and administration of salted fluids to correct the chemical imbalance.

Heat exhaustion (or prostration): an excessive pooling of blood in the extremities away from the brain, heart and lungs, causing dizziness, weakness and nausea. The skin is usually pale, cool and profusely wet with perspiration. Treatment involves cooling and fluid replacement, and possibly medical treatment if the condition is not soon reversed.

Heat stroke: by far the most serious of the high-temperature illnesses, a true medical emergency requiring immediate and aggressive cooling efforts. The body fails to eliminate excess heat and the internal temperature rises to a dangerous or fatal level. Total immersion in water is the most effective method of rapid cooling. Paramedics must be summoned to start intravenous therapy and provide transportation to the hospital. Heat stroke represents a disturbance of the central nervous system and is associated with a mortality rate of 20 percent.

in the county along with the homes between that property and Beulah Road. In the second unit, the Town would gain several lots at the end of Upham Place and Heritage Lane, while 11 lots off Lawyers Road adjacent to Vandervate Estates would go to the county. It has been recommended that 8 of the 11 lots be dropped from consideration after the majority of the property owners expressed opposition to a boundary change.

Overall, based on the staff recommendations, the Town would acquire an additional 71 acres of property and approximately 218 new residents.

September Hearing On Beulah Road

The Town Council will hold a public hearing on a project to reconstruct Beulah Road at 8 p.m. Monday, September 16, in the Council Chamber at Town Hall.

The Virginia Department of Transportation has proposed that the road be reconstructed with a 33-foot paved width; however, VDOT officials have indicated that the Town could use a 30-foot width if it wishes. The reconstruction would also include curb and gutter, and sidewalks on both sides of Beulah as well as storm drainage improvements.

The latest VDOT cost estimate for the project is \$3.2 million, of which the Town's share would be 2% or \$64,000.

Copies of the VDOT proposal should be on display at Town Hall by August 1, and at least two to three weeks prior to the public hearing the right-of-way for the project should be staked out along Beulah Road.

Immunizations Required Before Beginning School This Fall

The Fairfax County Health Department is extending regular clinic hours during August and early September to provide the immunizations required for school entry in Fairfax County. Parents should note that new state regulations require that all children enrolling in school for the first time, in either kindergarten or first grade, must have a second measles immunization.

Immunizations are offered at no charge, and no appointment is necessary. A parent, legal guardian or adult designee must accompany the child. Bring the child's immunization record and a translator, if needed. Parents are encouraged to come early to avoid the last-minute rush. The schedule for both extended and regular clinics is:

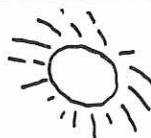

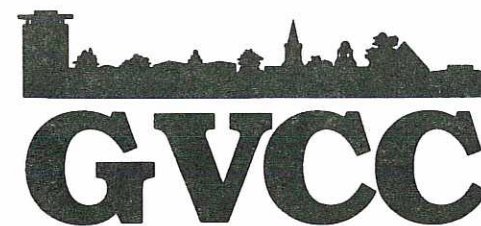
