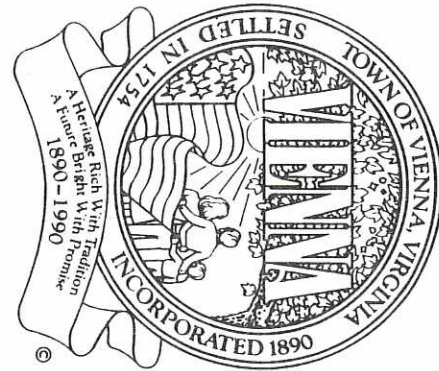

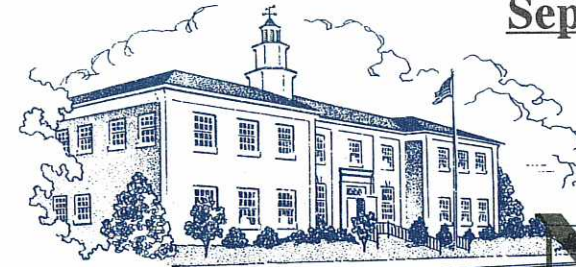

Public Hearing September 16 On Beulah Rd. Reconstruction

The Town Council will hold a public hearing on a project to reconstruct Beulah Road at 8 p.m. Monday, September 16, in the Council Chamber at Town Hall.

The Virginia Department of Transportation has proposed that the road be reconstructed with a 33-foot paved width; however, VDOT officials have indicated that the Town could use a 30-foot width if it wishes. The reconstruction

would also include curb and gutter, and sidewalks on both sides of Beulah as well as storm drainage improvements.

The latest VDOT cost estimate for the project is \$3.2 million, of which the Town's share would be 2% or \$64,000.

Copies of the VDOT proposal are on display at Town Hall, and the right-of-way for the project is staked out along Beulah Road.

NO SPECIAL PICKUPS IN NOVEMBER/DECEMBER

October 11 is the last day to call for a special trash pickup in 1991. No special pickups will be made in November and December because the Public Works Department personnel who make special pickups will be spending up to 12 hours a day collecting leaves.

Impact of Chesapeake Bay Act Should Be Minimal in Vienna

The Town Council's public hearing on the adoption of the Chesapeake Bay Preservation Act Map and Ordinance for the Town of Vienna is scheduled for Monday, September 30. The hearing will begin at 8 p.m. in the Council Chamber at Town Hall.

The Chesapeake Bay Preservation Act was adopted by the Virginia General Assembly in 1989. The Act requires all jurisdictions in the Virginia tidewater area to institute identification and protection measures for the improvement of water quality and the reduction of non-point source pollution. Even though Vienna is over

50 miles from the Chesapeake Bay, actions taken here are important to the bay's critical health.

After considering the Act for almost a year, the Town Planning Commission has structured the proposed ordinance so as to have minimal impact on homeowners while meeting the state-mandated regulations to protect the bay.

The ordinance identifies Wolftrap Creek with a 100-foot buffer on either side as a "Resource Protection Area" (RPA). This is the designation for the most sensitive of lands, which by virtue of their natural location and function are susceptible to pollution caused by construction and other human activities. Because nearly all residential properties in the RPA are also in the floodplain, the Town Code already severely restricts new construction activities.

The "Resource Management Area" (RMA) is identified along the town's intermittent streams, floodplains, areas with sensitive soil characteristics, and adjacent to the

Wolftrap Creek RPA buffer. These lands have the potential for degrading water quality and the RPA if improperly developed. The designation of the RMA generally follows boundaries of properties in the floodplain that are not in the RPA. Development and redevelopment in this area is allowed but subject to regulations controlling runoff where impervious surfaces of new construction would exceed the watershed averages as computed by the Department of Public Works.

It is anticipated that the additional effect of the ordinance on single-family properties in the RPA and RMA will be minimal. For more information, call the Planning and Zoning Department at 255-6341.

TOWN COUNCIL ACTION

JULY 1, 1991

- Held an executive session on pending litigation with Triangle Development Corp. regarding the subdivision bond for West End Manor Subdivision. The matter has been settled, with the developer agreeing to cover the cost of certain sidewalk improvements on Orchard Street.

- Made the following appointments for fiscal year 1991-92: Councilman Olson, Mayor pro tempore and representative to the Centreville District Citizens Park Advisory Council; Councilman Dix, representative to the Northern Virginia Planning District Commission; Councilman Seeman, representative to the Administrative Committee of the Town Employee Retirement Plan; Councilwoman Pruett, liaison to the Fairfax County School Board; Councilman Lovelace, representative to the Fairfax County Board of Supervisors; and Mayor Robinson, Councilmen Lillis and Olson, Town Manager John Schoeberlein and Town Attorney John Gionfriddo, Town Charter Review Committee.

- Approved a contract with Draper Aden Associates for engineering work on water system improvements at a cost of \$18,650.

- Approved Fairfax County school sidewalk projects for Tapa-wingo Road, Glyndon Street and Moore Avenue.

- Awarded a bid for tree maintenance and removal services for FY 91-92 to Able Services, Inc., of Lorton at the rate of \$85 per hour for a three-man climbing crew and \$95 per hour for a three-man bucket truck crew, with an anticipated cumulative expenditure of \$15,000.

A low-cost rabies vaccination clinic for dogs and cats will be held on Sunday, September 8, from 12 noon to 2 p.m. at the Fairfax County Animal Shelter, 4500 W. Ox Rd. The clinic is a cooperative effort of the Northern Virginia Veterinary Medical Association and the County Department of Animal control.

Vaccine given to dogs and cats over one year old provides protection from rabies for three years. The charge for this vaccine is \$6. Vaccine given to all dogs and cats under a year old provides protection from rabies for one year and costs \$4. Puppies and kittens should be at least three months old to receive vaccine.

When animals are brought to the clinic, dogs must be restrained on a leash and cats confined to a cat-carrier or other container.

Regional Planning Group Fosters Interjurisdictional Cooperation

As we move toward the 21st century, more local government elected officials, private sector representatives, and citizens alike are recognizing that many issues which have largely been addressed locally must now be examined on a regional basis.

The Northern Virginia Planning District Commission is the only regional entity that works with, advises and represents the interests of the local governments in the Northern Virginia region. Thirteen jurisdictions (Town of Vienna, Town of Herndon, City of Fairfax, Loudoun County, Town of Leesburg, City of Falls Church, Fairfax County, Town of Dumfries, City of Alexandria, Prince William County, City of Manassas, Arlington County, City of Manassas Park) are represented by elected officials and citizen appointees, based on their population. NVPDC is one of 21 planning districts in Virginia.

Issues such as land use, environmental management, economic development and transportation, along with many health and human service matters, are not restricted to the borders of an individual locality, and dialogue among affected governments is critical to the future success of planning and the implementation of the plans.

NVPDC seeks to facilitate interjurisdictional cooperation in many ways such as hosting regular meetings of public works directors, law enforcement officials, public information officers, chief administrative officers, planning directors and human services directors from member jurisdictions. These are just a few of the various advisory groups that NVPDC supports with staff and additional resources.

In addition, a number of

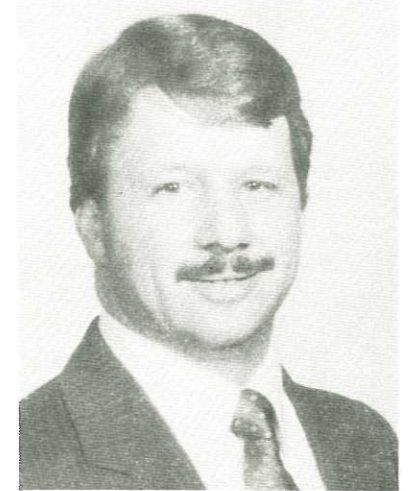
Commission subcommittees research and review issues of concern and forward policy recommendations and position statements to the full Commission. The subcommittees are: Land Use; Regional Resources; Human Services; Economic Development; Legislative; and Operations.

Recently, NVPDC sponsored its second land use conference for elected officials. Several members of the Vienna Town Council and planning staff participated in this conference with colleagues from throughout Northern Virginia.

Also, Vienna residents Martha Pruett, Lorraine Markoff and Bob Scott have been active participants in a solid waste management task force, looking comprehensively at recycling programs and solid waste management alternatives. The technical expertise demonstrated by the NVPDC professional staff in all work plan areas provides a readily accessible resource to all member localities.

This presentation gives only a thumbnail sketch of the programming activities, information systems, technical expertise and resource capability that exist at and through the Northern Virginia Planning District Commission, which stands ready to render assistance to any of its member governments in Northern Virginia.

I am honored to serve as the Town of Vienna's representative to NVPDC and to be the first Town official to be elected as Chairman of this prestigious collection of regional leaders in its 22-year history. I look forward to enhancing the concept of regionalism as we find the need for interjurisdictional cooperation to be more important than ever.

Four-way Stop Sign Etiquette Reviewed

Several years ago a Vienna resident wrote the following article to help educate the driving public on stop sign "etiquette." It is repeated here as a refresher about the rules that apply at intersections with four-way stop signs.

I have seen a large increase in the installation of four-way stop signs within the Town of Vienna and have also noticed an increase in confusion and sometimes anger displayed by drivers who think that I and others are breaking some right-of-way rules at such intersections when we are not. I have discussed driving rules that apply to intersections with four-way stop signs with the Vienna Police Department. What follows is my summary of these rules:

- When two or more vehicles approach the intersection, the vehicle that comes to a stop first has the right-of-way to proceed straight through or to make a left or right turn.

- When two vehicles traveling in opposite directions on the same street stop at the same time at the intersection, each may proceed without regard to the other unless one driver wants to make a left turn. In this instance the driver wanting to turn left must yield the right-of-way to the driver who desires to proceed straight through the intersection.

- When two vehicles stop at the same time at the intersection on different streets, the vehicle on the right of the other has the right-

of-way to proceed straight ahead or make a turn.

- For the same situation as above, if there is also a stopped vehicle behind the first vehicle, that vehicle has not yet reached the intersection and does not have the right-of-way over the stopped vehicle on the left. Right-of-way rules do not apply to second-in-line vehicles until they have moved up to the intersection and again stopped when the vehicle in front has moved on.

- When three vehicles all arrive at the intersection and stop at the same time, the vehicle on the right of the other two has the right-of-way. When this vehicle moves through the intersection, the driver on the right of the other remaining vehicle has the right-of-way to move first.

- If four vehicles stop at the same time on four different traffic lanes (an unlikely situation), none of the above rules can apply. One vehicle should proceed cautiously through the intersection, thus allowing the three-vehicle rule to apply.

In all situations, of course, turn signals should be used when required.

Lawn Care Affects the Bay's Water Quality

Looking for help with your lawn and information about how your lawn care program impacts local streams, watersheds and the Chesapeake Bay? Learn from the experts on Saturday, September 14, from 9 a.m. to 12 noon at the Izaak Walton League Park in Centreville.

This Urban Lawn Care Field Day will teach homeowners about lawn aeration, backyard composting, lawn fertilization, and lawn spreader calibration that will improve lawn quality and protect the Bay. Experts will come from the Izaak Walton League, the Virginia Cooperative Extension Service, and the Virginia Division of Soil and Water Conservation.

The highlight of the day will be a rainfall simulator demonstration that will compare the quality of a spring-fertilized lawn to that of a fall-fertilized lawn.

PHOSPHORUS & NITROGEN ARE THE CULPRITS

Excess fertilizer your lawn cannot use, usually in the form of nitrogen and phosphorus, washes off your lawn, into the storm drain, then dumps into the Potomac, and finally makes its way to the Chesapeake Bay. According to Virginia's Council on the Environment, about 8 million pounds of phosphorus and 60 million pounds of nitrogen enter Bay waters each year. There they promote excessive algae growth. When the algae bloom, they prevent critical sunlight from penetrating the surface of the water, harming the many species of life unique to the Bay that depend on sunlight.

Once the algae die, aerobic bacteria break them down and steal crucial oxygen from other life forms. Oxygen depletion causes fish kills, increases the amount of dead organic matter, decreases water

clarity, and increases the cost of water treatment.

You can reduce excess phosphorus and nitrogen going to the Bay by adopting a fall lawn care program of fertilizing, seeding and aerating to produce a better root system that absorbs more nutrients and produces less runoff. Also, if you raise the mowing height of

your lawn, the roots will be more shaded and hold water longer.

Don't waste water by using more than necessary. Water your lawn in the late evening or early morning so that the water can be absorbed by the roots, not evaporate into the air.
