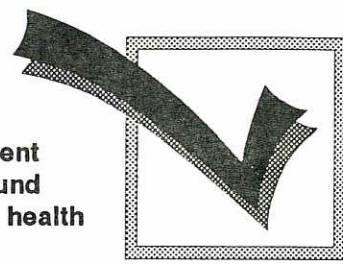

Holiday Closing

Real Estate Tax Due

The second installment on 1992 Town of Vienna real estate tax bills is due on December 5. Mailed payments must be postmarked on or before that date to avoid penalties. Your canceled check is your receipt. Vienna property owners who have questions or need assistance in filling out the form should call the Finance Department at Town Hall, 255-6325.

Leaf Collection Continues

Fall leaf collection will continue through the rest of the year. Department of Public Works crews are going through town vacuuming up piles of leaves that residents have raked to the curbside. Because of fall leaf collection, no special trash pickups will be made in November and December. For information about leaf collection, call the Public Works Department at 255-6381.

Peddlers, Solicitors Must Be Licensed

A peddler is defined as anyone who carries goods from door to door for sale and immediate delivery. Peddlers are required to pay a license tax to the Town and must display the license on their vehicles.

A solicitor or canvasser is defined as anyone who goes from door to door taking orders for merchandise or services to be delivered at some future date, or requesting donations for a charitable purpose. Canvassers and solicitors are required to obtain a license from the Town and to show the

license on request. They are also required to wear a badge issued and signed by the Town Clerk containing the words "Licensed Solicitor."

The Town Manager may grant exemptions from licensing requirements to non-profit groups. If an exemption has been granted, it will be on file at Town Hall.

Residents who suspect that a solicitor or peddler is operating under fraudulent pretenses or that he may be "casing" the neighborhood for burglary targets should call the police, 255-6366.

Town Council Action

AUGUST 17, 1992

- Conducted an executive session to interview Roger DeMarco for appointment to the Community Beautification Commission. He was subsequently appointed as a non-Chamber of Commerce member of the Commission.
- Adopted a resolution honoring former Fairfax County Supervisor Martha Pennino.
- Conducted a public hearing on an application to rezone property in the 100 block of Nutley St., S.W., from RS-16, single-family residential, to RTH, townhouses. (Hearing continued to receive further information.)

- Referred the matter of traffic control in the Follin Lane area back to the Transportation Safety Commission for further consideration. On receipt of the Commission's recommendations, Council will conduct a public hearing on the matter.
- Directed the Town Manager to draft a letter to the Virginia Department of Transportation requesting safety improvements for the pedestrian

crossing at Nutley Street and Marshall Road, S.W.

- Denied a request for a left-turn signal on Nutley Street, S.W., at Tapa-wingo Road.
- Approved certificates of distinguished service for Ronald Faett, Michael Dombrowski and William Beebe for their service on Town boards and commissions.
- Approved a change order in an amount not to exceed \$1,900 for modifications to the heating and air conditioning system for the fitness and supervisor's rooms in the basement of the new police station.
- Adopted an amendment to the residential permit parking ordinance lowering from 75% to 65% the percentage of total spaces that must be occupied for an area to qualify for establishment of permit parking.
- Awarded a bid for a trash truck cab and chassis to Central Motor Co. at a price of \$54,764, to be paid on a four-year lease purchase plan. This truck will replace one that is 12 years old and no longer practical to operate due to frequent breakdowns and rising maintenance costs.
- Awarded a bid for a rear loader refuse body to THC Enterprises, Inc.,

at a price of \$33,435, to be paid on a four-year lease purchase plan.

- Awarded a bid for sidewalk improvements to Owens & Dove, Inc., of Manassas Park at a price of \$223,375.32.

Did you know? The Vienna Community Center is a great place to hold children's birthday parties. The fee of \$10.50 per child (minimum 10 children) includes refreshments, party favors, paper supplies, and a variety of games and activities, including music, puppetry and tumbling. Parents take care of supervision and serving refreshments. Parties are scheduled on a space-available basis on Saturdays and Sundays at 11 a.m., 1 p.m. or 3 p.m.

Health Department Offers Flu Shots

The Fairfax County Health Department has scheduled special flu and pneumococcal pneumonia vaccination clinics at several sites this month. The vaccinations will be provided only to those at high risk: adults aged 65 and over, and adults and children with chronic cardiovascular or pulmonary disorders. Those under 18 must be accompanied by a parent or guardian and have a written physician's order.

There is a charge of \$7 for the flu vaccine and \$10 for the pneumococcal pneumonia vaccine. Medicare will not cover the cost of either vaccine. Medicaid will cover the cost of the vaccines only for those at high risk; recipients must bring their identification cards.

● Wednesday, November 11, from 9 a.m. to 3 p.m. at Wakefield Center, 8100 Braddock Rd. in Annandale. No appointment necessary.

● Friday, November 13, 9 a.m. to 2:30 p.m. at George Mason High School, 7124 Leesburg Pk. in Falls Church. No appointment necessary.

According to the American Lung Association of Northern Virginia, since 1979, flu and pneumonia have been the 6th leading cause of death in America, with 88% of the victims aged 65 and older. One of the biggest problems with the flu is that a person can be contagious before symptoms arise. Since new flu strains appear every year, a yearly flu vaccine is needed, especially for high-risk individuals.

1993 Dog Tags Available November 2

1993 Town of Vienna dog licenses will be available beginning Monday, November 2, in the Finance Department at Town Hall. All dogs over four months old must be licensed each year.

The fee is \$10 for a fertile dog and \$5 for an infertile dog. A current rabies vaccination certificate must be shown to obtain a license, and a spay/neuter/infertile certificate must be shown for a reduced price license.

Dog tags are also available by mail. Use the form below or call 255-6323 for more information.

Rabies Clinic

A low-cost rabies vaccination clinic for dogs and cats will be held Sunday, November 8, from 12 noon to 2 p.m.

at the Fairfax County Animal Shelter, 4500 W. Ox Rd. The clinic is sponsored by the Northern Virginia Veterinary Medical Association and the County Department of Animal Control.

Vaccine given to animals over one year old costs \$6 and provides protection from rabies for three years. Vaccine given to animals under a year old costs \$4 and provides protection from rabies for one year. Puppies and kittens should be at least three months old to receive vaccine.

When animals are brought to the clinic, dogs must be restrained on a leash and cats confined to a cat-carrier or other container.

1993 Town of Vienna Dog License Application

Town of Vienna licenses are required for all dogs four months of age or older and must be renewed each year between November 1 and January 31. The cost of a license for a spayed/neutered dog is \$5.00. The cost of a license for a fertile dog (male or female) is \$10.00. Certification must be provided that the animal has been vaccinated against rabies and, for a \$5.00 license, neutered by a veterinarian or is infertile. Your certificate(s) will be returned with the tag.

- Approved special business promotion activities in connection with Business Celebration Days October 17-25, sponsored by the Greater Vienna Chamber of Commerce.

- Rejected a proposed letter of credit for Vandervate Estates Subdivision. Reduced the public improvements bond to \$65,626.

- Voted to determine whether County funds would be available to help defray all or a portion of the cost of brick sidewalk in front of the Freeman House.

- Accepted the public improvements for Glyndon Woods Subdivision, Glyndon Street and Marshall Drive, N.E., into the Town maintenance system. Authorized the Town Manager to retain \$5,194.65 of the original public improvements bond as a two-year maintenance bond.

Citizen Comment

Questions About Trees and Bicycles

A Church Street resident writes:

I have three questions that I would like answered in our newsletter. . .

One: Why do I have to have a "permit" to cut down a tree on my own property? That is a bit ridiculous.

Two: Don't bicyclists have to obey highway laws, i.e., stopping at stop signs?

Three: There is a zebra crossing for bicyclists on Church Street between Mill and Dominion. Do cars have to stop when a cyclist is in the crossing? (I know that in California and England all traffic must stop the minute a pedestrian puts foot in a zebra crossing.)

Thank you for your answers.

The Department of Planning and Zoning requires residents to obtain a permit before any tree is "cleared or destroyed." The permit fee is \$5. Call 255-6341 for information. Also, it is illegal to cut trees on public property. If

you are unsure whether a tree is on your property or in the public right-of-way, check with the Parks and Recreation Department at 255-6360.

Bicyclists must obey the same traffic regulations as drivers of motor vehicles, including stopping at stop signs. Good brakes and a horn or bell are required for all bikes, and those ridden after dark must also have lights and reflectors.

Drivers of motor vehicles must yield to bicyclists and pedestrians in crosswalks. Before entering a crosswalk, make sure oncoming traffic will have enough time to come to a safe stop.

This same citizen would like to remind users of the Community Center recycling bins that recyclables should not be left lying on the ground around the bins. Please remember to flatten cardboard boxes to save space in the bins.

TDD's at Town Hall, Community Center

The Town Council has allocated \$15,000 to begin compliance with the Americans with Disabilities Act (ADA). The Act requires that all public facilities and programs be physically accessible to all citizens.

One of the first steps the Town has taken to accommodate disabled citizens is the installation of telecommunications devices for the deaf (TDD's) at Town Hall, the Community Center and in the Police Department, which are scheduled to become operational on November 1.

Effective immediately, all Town meetings, programs and events must be accessible. Citizens requiring special accommodations such as physical assistance or a sign language interpreter are requested to notify the Town at least three working days in advance. All publications and mailings will be made available in large print or on audio cassette upon request.

All departments are currently reviewing their facilities, programs and

activities to identify where operating policies and physical plant changes are needed. The most pressing issue at this time is the lack of accessibility within the Town Hall; rest rooms, public telephones, various offices and the Council Chamber are not open to the disabled. An architectural firm has been hired to evaluate the building and provide accessibility recommendations. The results of that survey are expected by December. All building renovations must be completed by January 26, 1995.

Also as required by the ADA, the Town Council has adopted a resolution implementing a grievance procedure to provide individuals with an avenue to resolve issues outlined in the Act. A complaint of discrimination must be filed within 180 days of the occurrence and must be acted on by the Town within 30 days of receipt. The procedure contains provisions for appeals to a Compliance Committee.

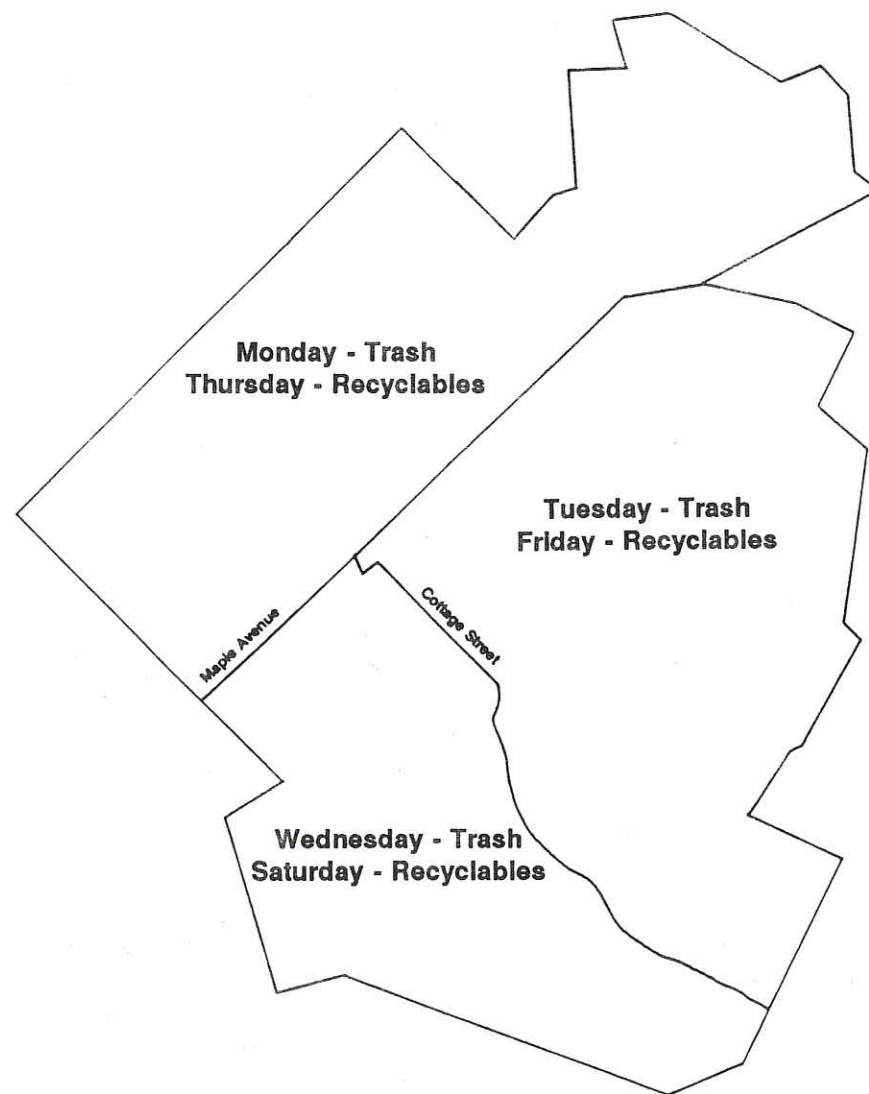
Curbside Recycling, New Collection Routes Effective Jan. 1

Beginning January 1, 1993, household trash and recyclables will be collected according to the following schedule: Monday/Thursday - Residences north of Maple Avenue; Tuesday/Friday - Residences south of Maple Avenue and east of Cottage Street; Wednesday/Saturday - Residences south of Maple Avenue and west of Cottage Street.

Residents will receive regular trash pickup on the first collection day each week, with the second collection day reserved for the following recyclable materials: newspapers, brush, grass, plastic bottles and jugs labeled #1 and #2, glass jars and bottles of all colors, metal food and beverage cans, and aluminum foil.

Plastic, glass and metal are to be placed together in the same blue or transparent plastic bags especially made for recycling. These bags are available at local stores. A coupon for a free box of bags will be mailed to each residence early next month.

Cardboard will not be picked up at curbside initially, but may be dropped off along with other recyclables in the recycling bins at the Vienna Community Center. This recycling center, which is now funded and operated by Fairfax County, will continue in addition to the Town's curbside recycling program.



Recycle Phone Books at Maple Avenue Shopping Center

The Donnelly One Book will be distributed throughout Northern Virginia beginning November 10, followed by distribution of the C&P Telephone directory in late January. Vienna residents are encouraged to bring their old telephone books for recycling to the Maple Avenue Shopping Center (Giant Food) parking lot from November through March.

A walk-in trailer has been provided for recycling, and phone books should be stacked inside as neatly as possible. Only phone books will be accepted at the site, which will be monitored by the Town staff. Please do not leave plastic bags, newspapers,

magazines, catalogs, or any other items.

The old books will be delivered to Metro Recyclers, where citizens themselves can drop off phone books year round. The address is 2801 Dorr Ave. in Merrifield, phone 207-9104.

Maple Avenue Shopping Center was the first public telephone book collection site in northern Virginia, and the Town thanks the shopping center management for again making the property available for this important community service.

The collection drive will help Vienna reach state mandated and locally adopted recycling goals as well as

reduce adverse environmental impacts caused by disposing of the books with household trash.
