Town Sells Bonds at Excellent Rate

The Town of Vienna has sold \$4.5 million in general obligation bonds at a total interest cost of 4.74 percent. The Town Council awarded the sale at a special meeting on May 25.

Eight bids were received from banks and investment firms, ranging from 4.74 to 4.89 percent. The winning bid of 4.74 percent, made by the investment firm Scott & Stringfellow of Richmond, is one of the lowest for general obligation bond sales in Virginia so far this year. Of the 35 bond issues across the U.S. on May 25, Vienna had the second lowest financing rate.

According to the Town's financial advisors, Government Finance Group of Arlington, the strong market demand for Vienna's bonds is because they are bank-qualified and highly rated by Moody's and by Standard & Poor's, which rated the new issue as Aa and AA-, respectively. Moody's cited the expenditure restraint and conservative management reflected in the Town's ample General Fund reserves as one of the reasons for its high-quality rating. Mayor Charles A. Robinson, Jr., commented, "This excellent rating proves the credit worthiness of the Town."

Proceeds from the bond sale will be used to finance Phase II of Vienna's Capital Improvements Program, which includes sidewalk construction

projects, modifications to Town facilities required by the Americans with Disabilities Act, water and sewer line improvements, street reconstruction, park improvements, and improved facilities for the Department of Public Works.

Citizens Express Concerns at Hearing On Park & Recreation Zone Proposal

At the Town Planning Commission's May 12 public hearing on the rezoning of certain Town-owned park properties from single-family residential to the park and recreational (PR) zone, a number of neighboring property owners expressed substantial concerns regarding the future use of those properties. The areas now being considered are Glyndon, Meadow Lane, Moorefield, Southside and Wildwood Parks, and the stream valley parkland in southeast and southwest Vienna. Northside Park, exclusive of the Town property yard area, will also very likely be considered for PR zoning.

As stated by members of the Town Council when the PR zone was created in 1991, the only purpose for the entire proposal is to prevent non-park development of land now used for park and recreation purposes. It is Council's intention that each park property remain either in open space or in its current recreational use. Accordingly, no additional more intensive recreational uses are contemplated for any of the properties involved.

In the past, when development of parkland was proposed, Council considered such development only after public hearings and a great deal of public input. For example, Council on at least two occasions has declined to install active recreational facilities at Northside Park. Nothing currently proposed would change Council's practice with respect to public input.

In an effort to ensure that the public is afforded as many opportunities as possible to comment on any future parkland development activities, the Planning Commission is also considering revisions to the PR zone ordinance itself that would mandate public hearings by the Commission and Council, along with notification of surrounding property owners, prior to changing any use of park or recreation properties.

It is anticipated that these ordinance revisions and a recommendation to Council with respect to the proposed changes in zoning will be finalized by the Planning Commission in late summer or early fall of this year.

The bonding company will complete the job according to approved plans, with the Town's financial liability limited to the contract price plus approved change orders.

- Accepted the public improvements for Malcolm Hollow Subdivision, 557 Malcolm Rd., N.W., into the Town maintenance system. Ten percent of the original bond will be retained for two years.

- Authorized the purchase of the 1993 July 4th fireworks display from S. Vitale Pyrotechnic Industries, Inc., in an amount not to exceed \$7,000.

- Made the following appointments to the Town/Business Liaison Committee for two-year terms: Steve Briglia and Maud Robinson, citizen representatives; Tyrell Brooke, Susanne Mull and Tom Parrott, Greater Vienna Chamber of Commerce business representatives; and Jim MacIntosh, Town Council business representative.

- Awarded a bid for silt removal to Atler B. Stanley & Sons, Inc., at a price of \$12,065.

- Took no action on a request to participate in the Fairfax County Community Development Block Grant program. Preparations will be initiated for possible participation next year.

- Approved a lot line adjustment between the properties at 516 and 518 Brentwood Ct., N.W.

- Requested the Transportation Safety Commission to develop a plan for traffic controls on Park Street, recognizing that it traverses a residential neighborhood, and review limiting truck traffic, speed controls and other devices necessary to ensure the safety of the neighborhood.

Planning an Accessory Structure?

The most commonly found structure in any residential zone with the exception of the residence itself is an accessory structure. Accessory structures include detached garages, detached gazebos, sheds, or any other secondary building erected on residential property.

If your planned accessory structure has an area greater than 150 square feet and/or is more than 8½ feet tall, a building permit is required. Three sets of building plans and three plats of your property showing the location of the accessory structure must be submitted along with a building permit application first to the Town of Vienna and then to Fairfax County for review and approval.

If your planned accessory structure has an area of 150 square feet or less and is not more than 8½ feet tall, a building permit is not required and you may proceed with construction adhering to the following regulations:

1. All accessory structures must be located in the rear yard. On a corner lot, it must be located beyond the building line of any adjoining lot.

2. It shall not be closer than five

feet to any alley line.

3. On an interior lot, it shall not be less than one foot from any side or rear lot line. On a corner lot, it shall not be less than five feet from any side lot line.

4. Where any portion is located directly behind the rear of the principal building, it shall not be less than 10 feet away.

5. Where no portion is located behind the rear of the principal building, it shall not be less than 15 feet away and also no less than 10 feet away from the extension of the rear wall line of the principal building on the adjacent lot.

6. Not more than 25% of the property can be covered by your house, garage, carport, driveway, patio, and accessory structure.

This information is only a summary of the regulations regarding the construction of accessory structures, and residents are urged to consult the Town's Planning and Zoning Department before erecting any structure. For more information, call 255-6341.

Burning of Trash, Leaves Is Illegal

Town of Vienna and Fairfax County fire prevention codes prohibit open burning of trash and leaves. Open burning is a safety hazard in urbanized areas and also a source of air pollution. The only exception is certain controlled burning with special inciner-

ation devices for land-clearing projects, which requires a permit issued jointly by the County Fire Marshal and the Air Pollution Division of the County Health Department.

DID YOU KNOW?

Adding ammonia to your trash before placing it at the curbside for pickup will help control odors and discourage animals and birds from tearing into the bags.

The Town Council has adopted a budget for fiscal year 1993-94 totaling \$14,501,681. Copies of the budget are available in the Human Resources Office at Town Hall for \$7.33 per copy.

The budget is based on a real estate tax rate of 30¢ per \$100 of assessed valuation, the same rate as last year. Due to a decline in total assessed valuation of property in town, this rate translates into an effective tax rate reduction of 3.32%.

An increase of 13¢ per 1,000 gallons in the water rate and an increase of 1¢ per 1,000 gallons in the sewer rate were approved to offset additional debt service requirements and increased operational costs. The total in-town rate for FY 94 is \$4.41 per 1,000 gallons, or about \$14 more per year for the average customer.

The Town's cigarette tax was increased from 15¢ to 20¢ per pack.

The budget was prepared based on a slow economic recovery, and all costs have been kept as low as possible, even though several cost increases such as landfill disposal fees and the price of water are beyond the Town's control. No new programs or services are included, but neither has any program or service been reduced. The workforce has been reduced by the equivalent of one full-time position, and capital purchases will be made only as necessary to maintain current operations. In lieu of a cost-of-living raise for employees, the Town will pick up the employee portion of Virginia Retirement System contributions.

Thanks for Special Olympics Support

The Vienna Police Department thanks the many individuals, organizations and businesses that contributed to the Law Enforcement Torch Run fund-raiser for Special Olympics. Vienna raised over \$2,000, helping Northern Virginia law enforcement agencies lead the state with a total of more than \$65,000. Statewide, an estimated \$200,000 was contributed for Special Olympics in Virginia.

Eight people from the Vienna Police Department participated in the torch run and opening ceremonies for the summer Special Olympics games held last month in Richmond.

The police are hoping for the community's continued generous support for the 8th annual torch run in 1994. Start watching for announcements in early spring.

Real Estate Tax Due

The first installment on 1993 Town of Vienna real estate tax bills is due on July 28. Mailed payments must be postmarked on or before this date to avoid penalties.
