## **Public Hearing January 24**

### **Council Considers Acquiring Lowe's**

The Town Council is considering acquisition of the Lowe's property at 143 Maple Ave., E., and has scheduled a public hearing for its January 24 meeting to receive citizen input on the idea.

This property, which is approximately 2.3 acres in area, occupies a prime location in Vienna's central

business district and abuts the W&OD Trail.

Two possible uses that have been mentioned for the site are a park and/or a municipal parking facility. More information about proposed uses and also the costs involved will appear in next month's *Newsletter*.

## **Town Completes ADA Transition Plan**

The Town of Vienna has completed its transition plan for compliance with the physical accessibility standards set by the Americans with Disabilities Act (ADA).

The plan identifies the modifications required to provide physical accessibility for all citizens at Town Hall, Vienna Community Center, Bowman House Arts & Crafts Center, and Glyndon and Meadow Lane Parks. Improvements will include handicap parking, elevators, and specially designed restrooms, drinking fountains, counter tops, and telephones. All modifications are to be completed by January 26, 1995.

The total cost for this project is estimated at \$454,102. Financing will come from general obligation bonds issued by the Town.

The Town invites public comment on the transition plan. Copies are available for review in the Town Clerk's Office and Public Information

Office at Town Hall, and at the Community Center. Large print or audio-cassette copies of the study may be obtained by calling the Public Information Office at 255-6330 (voice) or 255-5735 (TDD). Written comments on the study should be submitted by December 17 to: Nancy E. Novak, Director of Human Resources, Vienna Town Hall, 127 Center St., S., Vienna, VA 22180.

Individuals or groups who wish to conduct an independent on-site review of any Town facility to verify the study's results should contact the Human Resources Office at 255-6350 (voice) or 255-5735 (TDD). Five working days' notice is required for the visit to be scheduled.

The ADA, which was signed into law on July 26, 1990, bars discrimination against qualified individuals with disabilities in employment, public services, public accommodations, telecommunications, and public and private transportation.

### **Order Mulch Now**

The Public Works Department will begin taking orders December 1 for delivery of mulch to town residents free of charge. Deliveries will begin the second week of January. Order either ground leaf mulch or ground wood mulch; the minimum order for each type of mulch is a dump truck load. ### **Real Estate Tax Due**

# Town Council Action

All votes are unanimous unless stated otherwise.

## SEPTEMBER 16, 1993

- Authorized the Town Attorney, Town Manager and Mayor to arrange a final agreement with International Fidelity Insurance Co. for completion of the new police station.

## SEPTEMBER 27, 1993

- Requested the Transportation Safety Commission to consider the need for a four-way stop at Lewis and Orchard Streets, N.W.

- Following a public hearing, approved permanent zoning classifications for the Mobil and Shell stations brought into town last January in a boundary adjustment with Fairfax County.

- Approved a proposed agreement to participate in the Community Development Block Grant Program. The agreement must also be approved by Fairfax County and the U.S. Department of Housing and Urban Development.

- Approved the final plat for Driftwood Terrace, 1021 and 1023 Glyndon St., S.E. Directed the Town

staff to develop a method for reviewing each phase of subdivision construction.

- Extended for six months the contract with Cecil Goad as on-site Town representative during construction of the new police station.

- Adopted an amendment to the police retirement plan.

- Awarded a bid for a CAD (computer assisted drafting) system to Micro Computer Co. at a price of \$14,222.

- Amended the zoning code to eliminate the requirement for a tree removal permit except in cases of land subdivision or development.

## OCTOBER 4, 1993

- Approved a site plan modification and wall waiver for an addition to First Baptist Church, 450 Orchard St., N.W. Denied a request to waive required sidewalk improvements. (*Sidewalk waiver denied by a vote of 4 to 3; Garvie, Olson, Pruett and Seeman voted nay.*)

- Appropriated funds not to exceed \$5,730 for a topographic survey and drainage improvement plan for the 300, 400 and 500 blocks of Plum Street, S.W.

- Authorized replacement of 600

feet of water line on Talahi Road at an estimated cost of \$36,000.

## OCTOBER 25, 1993

- Continued until December 6 a public hearing on proposed amendments to the Town's cable television ordinance.

- Following a public hearing, adopted an ordinance to allow free-standing signs in transitional zones.

- Accepted with regret the resignation of Karen Martin from the Transportation Safety Commission.

- Approved a feasibility study, including costs, of an overpass across Maple Avenue at the W&OD Trail, a pedestrian activated traffic signal at that location, and rerouting of the trail along Park Street. The study will be performed by Tri-Tek Engineering at a cost of \$12,870.

- Awarded an engineering services contract for water system improvements to Tri-Tek Engineering in the amount of \$40,815.

- Approved preparation of preliminary streetscape plans for the Church Street revitalization project at a cost of \$4,000, to be reimbursed by Fairfax County.

- Authorized a refund of \$42.59 in penalties and interest assessed on the real estate tax bill of Richard and Josephine Pett, 907 Fairway Dr., N.E.

- Referred to the Planning Commission for public hearing and recommendation a proposed ordinance pertaining to inoperative motor vehicles.

- Adopted a resolution expressing concern about the effect of unfunded federal and state mandates on local government.

# ONE PERSON - YOU

We've all heard it said that "ONE PERSON can make a difference." I have never seen this to be more true than in the Town of Vienna. Sometimes one voice makes a change in the vote of the Town Council. However, on many occasions that one voice is speaking for the majority. I am addressing the ONE PERSON who can make a positive difference in our daily lives. You can be that ONE PERSON and you have the ability to change situations in Vienna. You have a powerful voice and you need to use it.

When I was deliberating as to whether I should run for Council, friends and neighbors encouraged me saying, "You can do it." However, ONE PERSON said, "I will be disappointed if you don't give it a try." These were the words that made the difference. You never know when you might be that ONE PERSON. As I walk around town asking questions about your concerns, it is apparent that many people have excellent ideas and could contribute these thoughts to our community. Whether you are helping feed a neighbor's cat or setting up soccer nets, you are that ONE PERSON who makes a difference in Vienna. You are that ONE PERSON who makes our town work.

We must be careful not to let the

wrong voice speak for us. Many times we are negative about an issue; however, we need to ensure that we have a positive solution. ## Commercial Vehicle Parking Rules

Parking of commercial vehicles for more than one hour in any 24-hour period is prohibited in all residential zones.

However, one commercial vehicle not exceeding 20,000 pounds gross weight may be parked overnight and on weekends and holidays off the street on the property of the vehicle's owner or custodian, provided that it is not moved or operated at any time for business purposes. Between the hours of 7 p.m. and 5 a.m. no commercial vehicle shall be operated, nor its engine run for any purpose whatsoever, nor be driven from its parked location.

Notwithstanding the above provisions, any commercial vehicle may be parked on a residential street for more than one hour while actually being loaded or unloaded or while the custodian of the vehicle is actively performing services in the area as long as the

residence is not that of the custodian of the vehicle.

### NOISE RESTRICTED IN WEE HOURS

The following activities are prohibited by the Town Code:

- Loading or unloading of commercial vehicles within 300 feet of a residence between 11 p.m. and 6 a.m.
- Servicing of trash dumpsters within 300 feet of a residence between 11 p.m. and 7 a.m.
- Idling of commercial vehicle engines for more than three minutes.
- Operation of refrigeration equipment on vehicles between 11 p.m. and 7 a.m. when parked for more than 10 minutes.

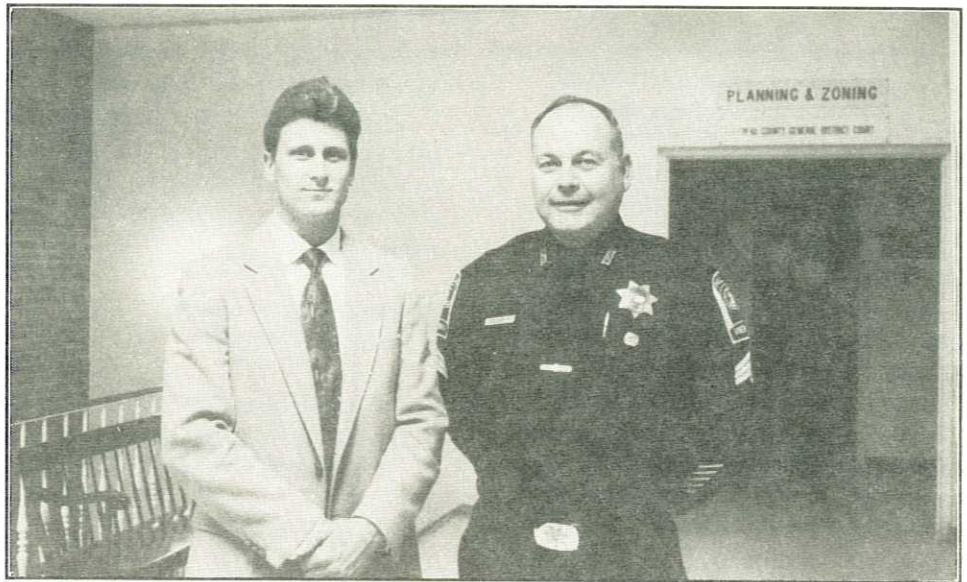

Certification must be provided that the animal has been vaccinated against rabies and, for a \$5.00 license, neutered by a veterinarian or is infertile. **REMINDER TO DOG OWNERS** - Please be a responsible pet owner and don't allow your dog to foul the lawns of neighbors. The Town has a "pooper scooper" ordinance that requires dog owners to clean up after their pets when out for a walk. In addition, walking of dogs is prohibited on playgrounds, athletic fields and picnic areas in Town parks because of the nuisance and potential health hazard to park users. The Town Animal Warden is authorized to fine pet owners found in violation of these laws.

# Safety "Rules of the Road" Are for Bicyclists of All Ages

As many of you already know, Fairfax County now requires children 14 years old and younger to wear a helmet when riding a bicycle. Many area jurisdictions are implementing this law to protect our children. The irony is that most of the bicycle-related complaints received by the Vienna Police Department involve the unsafe riding habits of adult cyclists.

Many children are taught bicycle safety at school and have the "rules of the road" fresh in their minds. The following summary is intended to help cyclists of all ages refresh their memories on the laws applying to the operation of bicycles in Virginia:

## Traffic Control

- Obey all traffic signs, signals, lights and markings. This includes stop signs.

## Where to Ride

- Ride with the flow of traffic on the right side of the road.
- Ride as close as possible to the right edge of the road, except when passing another vehicle, making a left turn, avoiding unsafe conditions, or when the lane width is too narrow to share with a motor vehicle. Bikes may also be ridden on the shoulder of the road.
- Do not ride between two lanes of traffic moving in the same direction, unless one lane is a separate or mandatory turn lane.
- Ride single file on streets. Bicyclists may ride two or more abreast on

paths or other other roadways designated exclusively for bike use.

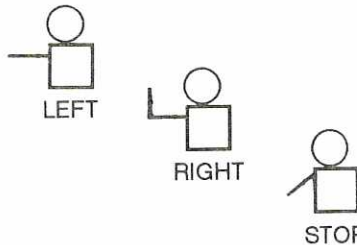
- Bicyclists are not permitted to ride on interstate and certain other controlled access highways. The restricted sections are marked with conspicuous signs.

## Riding on the Sidewalk (Vienna ordinance)

- Children under 11 years old may ride a bike on any sidewalk.
- Bicyclists of any age may ride on sidewalks wherever it is hazardous to ride in the roadway.
- No one is permitted to ride a bike on a sidewalk in any private shopping center.
- Always yield the right-of-way to pedestrians on sidewalks.

## Changing Directions

- Signal your intention to stop or turn with the left arm as follows. Signals do not have to be given continuously if both hands are needed to control the bike.



- Bicyclists may make left turns either as motorists or pedestrians do. To make a pedestrian left turn, continue straight across the intersecting road, obey the traffic signals, turn left at the corner, and proceed as usual. Bicyclists may also dismount and walk in the crosswalks.

## Passing

- Overtake and pass another vehicle only when safe to do so. You may pass on the right or left, stay in the same lane or change lanes, or ride off the road if necessary for safe passing. Please note that passing motor vehicles on the right side can be extremely dangerous if the motorist does not see the bicyclist and attempts a right turn.

- Motorists must approach and pass a bicyclist at a safe distance and reasonable speed.

## Accidents

- You must stop if you are in an accident involving death, injury or property damage and give your name and address to the police and to any other person in the accident. If unattended property is damaged, you must make a reasonable effort to find the owner. If the owner cannot be located, you must leave a note in a conspicuous place at the accident site and report the accident to the police within 24 hours.

## Equipment

- Earphones may not be worn while riding a bike.
- Bikes ridden after dark must have a white headlight visible for at least 500 feet and a red reflector visible for 300 feet to the rear. A red light visible for 500 feet to the rear may be used in place of or in addition to the reflector.
- Bicycles ridden on roadways must have brakes that make the wheels skid on dry, level, clean pavement.

## Registration

- Vienna residents are encouraged to register their bikes with the Police Department to help deter theft.
